

Emerging Leadership Council 2025-26 Guidelines

Emerging Leadership Council Purpose: A hybrid and interactive leadership development program that helps develop future leaders' unique leadership styles and make an impact on their team's performance and within their organizations.

Membership Guidelines:

- Candidates are nominated by leadership at MEMA OE Suppliers member companies (OE suppliers, commercial vehicles, and affiliate member companies).
- Candidates are on a "leadership track" and/or considered to become a future leader within your organization.
- Age requirement: Generally, 38 years of age or under are eligible.
- Candidates should have at least <u>five years</u> of industry experience and additional years of relevant professional experience.

Council Highlights:

- Council Members can participate in-person or virtually.
- An engaging and collaborative environment where emerging leaders learn and grow professionally and personally.
- Industry networking with OESA facilitators, subject matter experts, CEOs, industry executives, and thought leaders.
- The ELC cohort will participate in developing their program based on the issues that matter most today and in the future.
- Peer-to-peer roundtable sessions help foster connections with each other and create space to share best practices and actionable insights.
- Hands-on exercises, group discussions, breakout rooms, and polls to ensure engagement during the two years.
- Online learning provides an opportunity to bring people who might otherwise have limited opportunities to connect face-to-face due to restricted travel.
- The first ELC 25-26 meeting is on January 21, 2025.

Council Structure:

- Attendance at meetings is limited to council members and invited speaker guests.
- The Council meets quarterly for two years, beginning on January 21, 2025.
- Council members must attend at least two meetings per year to remain in good standing.
- Substitutions are not allowed.
- Council membership is a two-year commitment for 2025-2026.
- MEMA OE staff will administer and facilitate each meeting.
- The council membership is capped at 40 members, with a maximum of two nominees per supplier and commercial vehicle member company and one nominee per affiliate member company.

Additional Member Benefits:

- ELC members may be invited to participate in other MEMA OE Peer Group Councils as appropriate.
- ELC members are eligible to attend most MEMA OE events without cost or at a discounted rate.
- Facility tours/company visits exclusively to ELC members based on interest and availability.

Membership Fees:

- ELC is open to current MEMA OE Supplier regular and affiliate members and Commercial Vehicle companies only. The fee for this two-year program is \$3,800 per individual council member, which will be invoiced to the ELC 2025-26 members in January 2025.
- The council membership fee <u>must be paid in full by February 28, 2025.</u>
